CALL TO ORDER

INTRODUCTION OF STAFF AND GUESTS

President Higel asked for review and possible action on the Resolution authorizing Greg Higel to sign at closing for real property being purchased by Subdistrict No. 3. Amber Pacheco gave an overview of the purchase and an update on the CWCB loan. She reported Subdistrict No. 3 was working with the Trinchera Subdistrict on the purchase. Ms. Pacheco provided the deadlines and explained the resolution which was being required by the title company for closing. President Higel suggested creating a resolution that would authorize the President or Vice-President to sign at all closings.

A motion was made by Cory Off to approve the resolution as amended to include authorizing the President or Vice-President to sign for the Rio Grande Water Conservation District at closings. The motion was seconded by Mark Deacon and unanimously approved.

Clinton Phillips provided an update on the approval of the Subdistrict No. 3 SWSP for Alpha Hay Farms. He provided the acre-feet of surface water consumptive use and the acre-feet of historical groundwater consumptive use. Amber Pacheco explained how the water from the purchase would be used as a replacement source.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE RIO GRANDE WATER CONSERVATION DISTRICT

RECITALS

WHEREAS, the Rio Grande Water Conservation District ("District") was created pursuant to section 37-48-102, C.R.S.; and,

WHEREAS, pursuant to section 37-48-108, C.R.S., the Rio Grande Water Conservation District is authorized to establish special improvement districts; and

WHEREAS, pursuant to the request of certain water users within the Conejos Response Area and section 37-48-123, C.R.S., the District filed a Petition to establish Special Improvement District No. 3 of the Rio Grande Water Conservation District ("Subdistrict No. 3") in the District Court, Conejos County, and said Court approved said petition on October 16, 2016; and

WHEREAS, Subdistrict No. 3 as a local government entity is authorized to establish a water activities enterprise pursuant to Article 45.1 of Title 37 of the Colorado Revised Statutes and Subdistrict No. 3 has established a Water Activities Enterprise ("WAE"); and

WHEREAS, the mailing address of the District is 8805 Independence Way, Alamosa, CO 81101; and

WHEREAS, on April 15, 2022, the District, for and on behalf of the WAE of Subdistrict No. 3, entered into a Lease and Option to Purchase Agreement with Alpha Hay Farms, LLC ("Alpha Hay"), which was duly extended on February 16, 2023, nunc pro tunc, January 1, 2023, by an Extension of Option and Diligence Lease Term Agreement (collectively, the "Lease and Option to Purchase"); and

WHEREAS, under the Lease and Option to Purchase, Alpha Hay, *inter alia*, granted the District, for and on behalf of the WAE of Subdistrict No. 3, an exclusive, irrevocable option to purchase the real property described in Exhibit A (the "Property"), including certain surface and groundwater rights (the "Option"); and

WHEREAS, the District previously authorized the purchase of the Property and exercised the Option; and

WHEREAS, the Board of Directors of the District ("Board") now wishes to provide the following statement of authority showing who may act on behalf of the District, Subdistrict No. 3, and/or the WAE to convey, encumber, or otherwise affect title to real property for the purposes of closing on the purchase of the Property.

RESOLUTION

NOW THEREFORE, be it resolved by the Board of Directors of the Rio Grande Water Conservation District that:

- 1. The Board affirms that the District is authorized to purchase the Property.
- 2. Greg Higel, President, Rio Grande Water Conservation District, may act of behalf of the District, Subdistrict No. 3, and/or the WAE to convey, encumber, or otherwise affect title to real property for the purposes of closing on the purchase of the Property.
