The next quarterly meeting for Subdistrict No. 6 is scheduled for November 5, 2024 at 1:30 p.m.

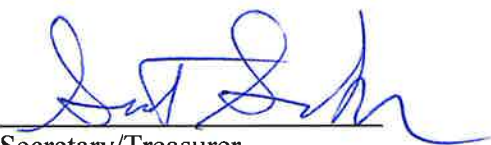
Adjournment
